The KANAWHA VALLEY COIN CLUB will sponsor its annual spring coin show at The Charleston Civic Center Quarrier St @ Elk River, Charleston, West Virginia on March 5th and 6th, 2011. The Parlor Room 105 been reserved for both days. This is the room normally used by the Coin Club and allows for loading from the rear doorway. The hours of the show are as follows:

**Saturday March 5th - 10:00AM to 5:00PM**  
**Sunday March 6th - 10:00AM to 4:00PM**

Dealers with tables may enter at 8:00AM on Saturday and at 9:00AM on Sunday.

The bourse fee of \$125.00 for one eight foot table and any additional tables @ \$125.00 each, and includes backup table, chairs, and electrical outlets. A 10 percent early discount is available for all tables paid in full by February 15<sup>th</sup>.

Each dealer will be responsible for any cases, covers, lights, or electrical cords. Every effort will be made to accommodate individual table location wishes, however, because of limited table options, requested and/or prior show locations may not always be available.

The **CHARLESTON CIVIC CENTER will hire security**, which will include only overnight security on Saturday evening. Admission to the show will be free, there is off street parking in the Civic Center garage, and there are food vendors nearby to the show premises.

**Limited tables are available and we again expect all tables to be sold.
